The College's Legal Aid Cell is very actively involved in the Legal Aid Activities of its own and also working in collaboration with District Legal Services Authority, Thane. The College is working in legal aid activities, since its inception. We have formed our legal aid devoted office/room in 2012.

We have included the legal aid work as a part of the student's practical work. Apart from the compulsory field/practical work many of our students voluntarily participated in the legal aid activities. Many of them are working as Para Legal Volunteers. The Ld. Secretary, DLSA, Thane has appreciated our work. Hon'ble former Chief Justice of India Shri. Uday Lalit also appreciated our legal aid activities and issued a certificate to us.

In the academic year 2023-2024, our legal aid cell has done lots of activities. The list and summary of the same is attached herewith.

I thank the Ld. Secretary of District Legal Services Authority, Thane Shri. Ishwar Suryawanshi for his support and guidance. The Support of VPM Management and the In-Charge Principal Dr. Srividhya Jayakumar encourages all our students to take up these activities.

01.03.2022	The college has organised a workshop on examination of witnesses in the moot court room. This was kept open for by demonstrating to law college students. The college undertook this activity to understand what actually happens in the court. before the court how witnesses are examined during a trial. How the record of statement made during examination is recorded in court and then how the same witness is cross-examined. This is the most of any case is an important part, whether it is a civil or criminal case. Our college is conducting these activities since last two-three years. The proceeding started with the permission of the presiding officers. Shailesh, the first

witness/complainant was examined by Prof. Vinod H Wagh, who was playing a role of public prosecutor. Mr. Ambar Joshi played a role of defence lawyer. Mr. Sandesh Gawand is currently API in Rabodi Police Station. In preparation for the workshop, he played a valuable role. Shri Sanjay Bhate who is former Additional District Judge and Visiting faculty in our college acted as the presiding officer judge. This workshop was designed with third year law students in mind but First Year Law and Second Year Law students were also invited. All students Participated wholeheartedly in the workshop. After the main exam their Cross-examination was also conducted. Overall, it was an amazing workshop and all the students really enjoyed. At this time Adv Bhate guided the students about examination and cross-examination and the skills required.

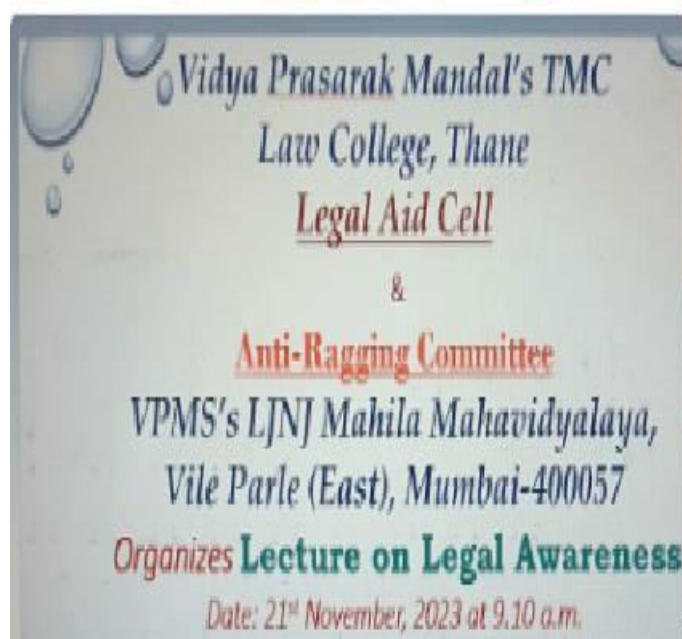

Since law college inception we are engaged in Legal Awareness Activities. Justice Shrikrishna Iyer had been to our college in late 1980 to promote Legal awareness.

The College has established 'Legal Aid Clinic' (Known as Legal Aid Cell) which shall open for all the poor and needy people on every Friday and Saturday. The Legal Aid Cell office is located on first floor of the Law College Building.

In 2022-2023, the Legal Aid Cell has conducted the following programs;

Para Legal Volunteers

37 students from First, Second and Third year LLB were admitted as PLV by the Thane District Legal Services Authority, Thane.

These students shall work for DLSA and also for the Legal Aid Cell of the College. These students do participate in different legal awareness activities as instructed by the DLSA and College Legal Aid Cell.

Azadi Ka Amrut Mahostav

Azadi ka Amrut Mahostav was celebrated with full joy and happiness by our college. Many programs related to legal awareness and patriotism were organised. The students were given the Indian flag in the class room. They were informed about how to keep these flags and the code of flag. The students performed many acts, elocutions and speeches in college as well as in different areas of the Thane city.

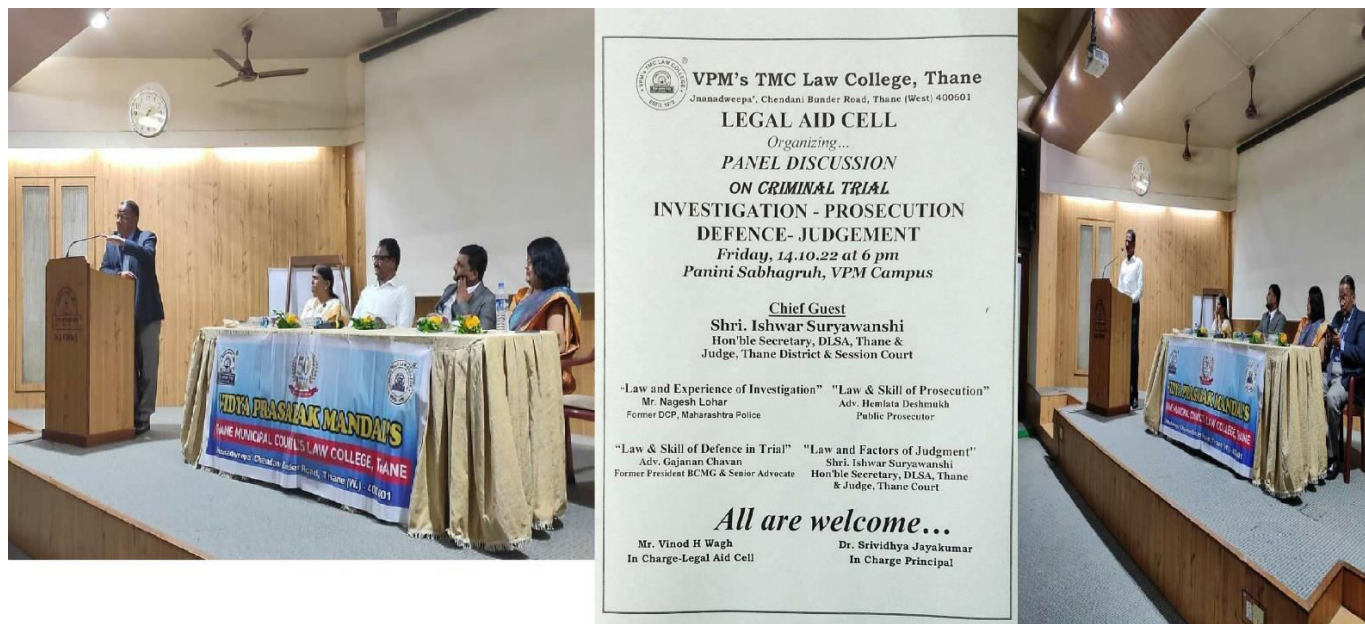
Thane Jail Visit

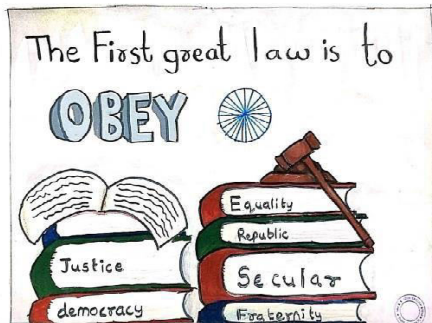


Essay and Drawing Competition
